

NEW ORGANICS REDUCTION AND RECYCLING LAW (SB 1383) IS NOW IN EFFECT

Beginning January 1, 2022, California's Senate Bill (SB) 1383 requires all multi-family property owners/managers to:

- Subscribe to recycling and compost (organics) collection services.
- Place color-coded and labeled recycling and compost containers next to indoor landfill containers.
- Ensure materials are sorted into the correct containers through periodic inspections.
- Inform tenants no later than 14 days after move-in and at least 14 days prior to move-out about SB 1383 requirements.

Why Should I Compost?

When compostable materials like food scraps, food-soiled paper, and yard trimmings break down in landfills, they produce methane, a harmful greenhouse gas 80x more potent than carbon dioxide. When we place these materials in the compost bin/cart instead of the landfill, we reduce methane emissions, address climate change, and create compost – a valuable soil amendment.

Food Scraps Kitchen Pail and Recycle Tote Bag

Recycle Tote Bags and Food Scraps Kitchen Pails are available for every multi-family resident. Use your Recycle Tote Bag to separate and transport recyclable materials to the Recycle Bin/Cart. Use the Kitchen Pail to separate and transport all food scraps and food-soiled paper to the Compost Bin/Cart. Keep the Recycle Tote Bag and Kitchen Pail for reuse. You may line your Kitchen Pail with paper towels, newspaper, kraft paper, or BPI-certified compostable bags. Do not place food scraps in non-compostable bags.



Contact your property manager to request a Recycle Tote Bag or Kitchen Pail at no additional cost.

Household Hazardous Waste (HHW) Drop-Off

It is illegal to place household hazardous waste (HHW) such as cleaning products, fluorescent bulbs, medications, paints, and chemically treated wood in any recycle, compost, or landfill bin/cart. Safely dispose of these items for free at an Alameda County HHW Drop-off Facility or County-sponsored events throughout the year. NO

Compostable and landfill materials, plastic bags, unlabeled plastics and plastics labeled ♻️-♻️, Styrofoam products, hoses and wires, household hazardous waste.

LANDFILL

Lined food/beverage cartons and pouches, plastic bags and wrappers, unlabeled plastics and plastics labeled ♻️-♻️, Styrofoam products, pet waste, personal hygiene products, other household items.

NO

Recyclable and compostable materials, construction debris (brick, dirt, concrete) or household hazardous waste.
