
# Bay Area Deconstruction Workgroup Webinar



The preservation of structures mirrors the pinnacle of waste prevention and reusing building materials by deconstructing older structures instead of demolishing and landfilling helps achieve carbon mitigation, zero waste and circular economy goals.

This webinar will pinpoint overlapping areas between the historic preservation and deconstruction and salvage movements and explore these intersections, which are rooted in the growing international climate heritage movement that aims to bring cultural heritage practitioners to the forefront of climate action. Our featured presenter Stephanie Phillips, City of San Antonio's Senior Historic Preservation Specialist, will share information on the city's ongoing deconstruction and policy initiative as a case
